RECRUITMENT

Walk-in interview for post of Junior Research Fellow (JRF) in an I.C.M.R. funded research project entitled 'Artificial intelligence aided computational approach using clinical laboratory markers to predict response to hydroxyurea therapy in Indian patients with sickle cell disease' is to be conducted. The details of position are as follows:

Number of posts: 01 (Un-reserved)

Essential Qualification:

Candidate must have a M. Sc./ B. Tech. in Biotechnology/ Bioinformatics/ Biochemistry (Preference will be given to ICMR JRF/UGC-CSIR JRF candidate).

Desirable Qualification:

Experience in Computer Applications is desirable.

Upper age limit: Not more than 28 years.

Job Description: Conducting rigorous clinical biochemistry lab experiments, data collection and data analysis and *In-silco* modeling.

Consolidated Emoluments: Rs. 25,000/- + HRA@ 20%

Tenure of Project: 03 Years

The Terms & Conditions for the posts are as follows:

1. The post is to be filled up only on **purely temporary basis** for one year and will be renewed annually after evaluation of work.
2. The project started on 16th March 2017. The duration of the project is for three years.
3. The appointment can be terminated with one month notice or one month salary from either side without assigning any reason.
4. Since the post is purely temporary, the incumbent selected will have no claim for regular appointments under Sickle Cell Institute Chhattisgarh, Raipur/ICMR or continuation of his/her services in any other project.
5. Benefits of provident fund, CCA, Leave Travel Concession, Medical Claim etc. are not applicable.
6. Age relaxation is only for SC, ST & OBC candidates as per C.G. State Govt. Rules.
7. No TA/DA etc. will be given to attend the Interview or joining of post and candidate should make his/her own arrangement for stay for interview and joining of post.
8. Qualification and experience should be from a recognized university.
9. Experience will be counted only after completion of essential qualification.
10. Mere fulfilling the essential qualification does not guarantee for the interview call and selection.
11. Eligibility, experience and age will be considered as on the last date of application.
12. Canvassing in any form will lead to disqualification.
13. Persons already in regular time scale service under any Government Department / Organizations are not eligible to apply.
14. Consolidated salary of the post may be revised as per ICMR instructions.
15. M. Tech. degree will be treated equivalent to two years experience as per ICMR order No. 16/107/2008-Admn.II dated 24/08/2016.
16. The selected candidate will work in the project mentioned above and on any other work that may be assigned by the Principal Investigator from time to time.
